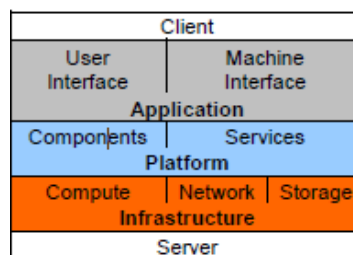


Figure 1.Cloud Computing Stack

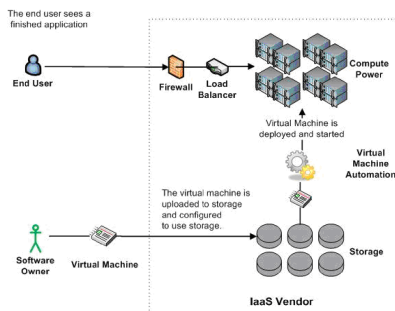


Figure 2. Infrastructures as a Service [10]
